Netball Tasmania - OfficiatED Grants

The purpose of this grant is to allow Tasmanian netball clubs or associations the ability to apply for financial assistance for the development of coaches, umpires and bench officials.

6.1 CRITERIA

- Association or club group applicants must be an affiliated and financial member of Netball Tasmania
- Individual applicants must be a current Netball Tasmania registered member and participate in officiating in one of the three branches of OfficiatED at an affiliated association or club
- Applicants must demonstrate their dedication to development and the accreditation pathway
- Applicants must be able to clearly detail how grant funding would be used to develop their knowledge and skills in their nominated branch, and in turn how that could enhance their club, association or Netball Tasmania
- Have a current Registration to Work with Vulnerable Persons

6.2 PROCESS FOR GRANT APPLICATION

- Each Netball Tasmania affiliated association or club playing within an affiliated association can submit one application to Netball Tasmania annually on behalf of a group of officials, or
- Individuals the meet the above criteria can submit one application annually
- Netball Tasmania will distribute a dedicated online form through which associations/clubs/individuals can apply
- All details on the nomination form must be completed
- Nominations must be submitted to Netball Tasmania by the closing date as advertised each year

6.3 SELECTION OF GRANT RECIPIENTS

- A Netball Tasmania panel will be responsible for selecting the recipients of the grants
- There isn't a set number of grants available, as the number of individuals/clubs/associations that may apply is highly variable, however, the total maximum value of OfficiatED grants available per annum is \$3000
- It is at the discretion of Netball Tasmania as to how many grants are issued and their dollar value in any given year
- The panel's decisions are final; no correspondence will be entered into
- An applicant may only receive this grant once every 2 years

6.4 ENTITLEMENTS

- Grants could be in the form of payment to educators/facilitators (e.g. umpire coaches, course presenters or assessors), subsidies for online/face to face course fees, subsidies for travel to participate in development opportunities, etc
- The successful grant applicants will be announced before the second Friday in November annually and will be notified by Netball Tasmania

- Successful grant applicants must also share/promote via their online and social media channels how the grant was used

 Should a successful grant applicant fail to undertake learning or courses by the deadline specified they will be liable to reimburse the sum received back to Netball Tasmania
